Practice Profile

Hereward Phillpot KC took silk in 2015, and has rapidly become recognised as one of the foremost practitioners at the planning and environmental bar. As a junior, the Chambers and Partners guide consistently rated Hereward as a 'Star Individual' junior in the field of planning, including him in the Chambers 100 UK Bar List of the top juniors, and naming him 'Junior Barrister of the Year' in environment and planning. Before taking silk, Hereward was a member of the Attorney General's 'A' Panel of Junior Counsel, having previously served on both the 'B' and 'C' Panels.
